Charges concerning rights and fees of third parties are subject to changes or amendments. The Bank is under obligation to withhold any tax as provided for in the applicable law and to discharge any other relevant legislative and regulatory obligations.

The term Average Portfolio Valuation Value means the average value of the Portfolio, taking into account its valuation each day of the period to which the calculation refers. The calculation of the value of the Portfolio is carried out on the basis of the valuation methods of Law 4099/2012 on UCITS, as applicable.
